

## « Contest RésoSanté »

### Rules and details of the contest

#### 1. Description and duration of the contest

The contest is hosted by [RésoSanté Colombie-Britannique](#). The contest runs from January 15, 2019 (9:00 am PST) to February 27, 2019 (11:59 pm PST).

#### 2. Eligibility

Only those who meet the following conditions can enter the contest:

- Reside in British Columbia
- Be 18 years old and over.
- Be a health professional who offers services in French in British Columbia.

#### 3. Participation

3.1 No purchase or consideration is required.

To enter the contest, the eligible person must meet the following conditions:

3.2 Register on the online directory of RésoSanté Colombie-Britannique or if you already have a profile, check if your information are up to date.

3.3 Fill out the participation form by giving your full name, city, postal code, phone number, email address and check the case if you're a RésoSanté member.

3.4 Submit the answer to the mathematical question.

3.5 Confirm that you have read and accepted the contest rules.

3.6 Click the Submit button to submit the form.

3.7 Limit of one participation per professional.

3.8 None of the replies submitted shall use vulgar, obscene or bad language, or which may affect RésoSanté image, as judged by the contest organizers.

3.9 In these cases, the answers will not be accepted and the participants concerned will be disqualified.

3.10 RésoSanté reserves the right to delete any response deemed inappropriate or offensive and to take any action necessary to remove such content.

#### **4. Price description**

Prize worth 500\$

The prize will consist of the following: (1) An annual pass for the Whitecaps FC season including 17 MLS home season games and the semi-final of the Canadian Championship, 47% discount for your (1) friend and 15% discount for the Whitecaps FC official store.

#### **5. Awarding of the prize**

Prize: The winner will be determined by computerized draw among all eligible entries. The draw will take place on Thursday, February 28, 2019, 11 am, at ResoSanté in Vancouver. The chances of a participant's name being randomly drawn depend on the number of eligible entries received.

#### **6. Publication of the winner's name**

#### **7. Property**

Replies submitted and declaration and release forms are the property of the Contest organizers. They will be used to update the information available on the directory as well as the contest winner's name on the RésoSanté BC website and ResoSanté BC's Facebook page.

## **8. Terms and conditions**

In order for the selected person to be declared a winner, the following conditions must be met:

- A member of the RésoSanté team will contact the selected person by email no later than one week after the draw. The winner must be contacted within 10 days, failing which the winner will lose his right to the prize. The prize will then be awarded to the next person, whose name has been drawn, and the same procedure will be following until the winner is named. The method of awarding prize will be decided with the winner by phone.

- If the contest winner resides in British Columbia, the prize may be claimed only by itself and will release RésoSanté from any liability for damages or loss arising from participation in this contest, the award or the use of the prize, its quality, any defect or loss in transportation, by signing the declaration and release form (the "Declaration Form"). The declaration Form will be sent by the contest organizers by mail, fax or email and must be returned duly signed to the contest organizers within 7 days or receipt.

- Within 15 days of receipt of the Declaration form, the contest organizers will provide the winner, by telephone, email or fax, information regarding how to take possession of the prize. In case of refusal of the selected person to receive his prize, it may transfer it to a person of his choice.

- Failure to comply with one of the conditions mentioned above or any other condition mentioned in these rules will result in disqualification of the selected entrant and a new draw for the prize will be made in accordance with these contest rules. The same conditions will then remain applicable by making the necessary adaptations, if necessary.

## **9. Verification**

Entries and Declaration Forms are subject to verification by the Contest Organizers. Any entries or Declaration Form which is, as the case may be, incomplete, inaccurate, illegible, reproduced by hand or mechanically, mutilated, fraudulent, obtained from an unauthorized source, filed or transmitted late, with an invalid or otherwise non-compliant telephone number, may be rejected and will not give entitlement. as the case may be, to an entry or prize.

## **10. Disqualification**

The contest organizers reserve the right to disqualify a person or cancel one or more registrations of a person if he / she participates or attempts to participate in this contest by using a means contrary to these rules or that is likely to be unfair to the other participants. This person could be delivered to the competent judicial authorities.

### **11. Course of the competition**

Any attempts to sabotage the legitimate conduct of the contest constitute a violation of the civil and criminal laws. If such attempts are made, the contest organizers reserve the right to reject the entrant's entries and obtain redress under the law.

### **12. Replacement and award**

If unable to provide the prize, RésoSanté reserves the right to replace, in whole or in part, a prize of approximately equivalent value.

### **13. Price limit**

In any case, the contest organizers can not be held to award more prizes or to award a prize other than in accordance with these rules.

### **14. Acceptance of the prize**

Prizes must be accepted as is and may only be transferred to another person.

The winners agree to sign a Declaration and Release Form prior to obtaining their prize.

## **16. Limitation of liability: operation of the contest**

The Contest Organizers and the persons for whom this contest is held are not responsible for the malfunction of any computer component, software or communication line with respect to the loss or absence of connection with any transmission that is faulty, incomplete, incomprehensible or erased by any computer or network and which may, for any person, limit the possibility of reading or preventing the participation rules. The contest organizers also disclaim any liability for any damage or loss that may be caused, directly or indirectly, in whole or in part, by downloading any web page or any software or other and by the transmission of any information to participate in the contest.

## **17. Limitation of liability : registration**

The Contest Organizers and the persons for whom the Contest is held will not be responsible for lost, misdirected or late entries, including those due to a postal service problem or any failure, for for any reason whatsoever, from the Website during the duration of this Contest, including any damage to a Participant's computer.

The Contest Organizers reserve the right, in their sole discretion, to cancel, terminate, modify or suspend, in whole or in part, this contest, in the event or intervention occurring may alter or influence the administration, safety, impartiality or conduct of the contest as provided in this By-law, subject to the approval of BC Gambling, if required.

Personal information collected from entrants in the Contest will only be used for the administration of the Contest. No communication, commercial or otherwise, unrelated to this contest, will be sent to entrants unless otherwise agreed.

## **24. Divisibility of paragraphs**

If a paragraph of these rules is declared or deemed illegal, unenforceable or invalid by a competent court, then this paragraph will be considered invalid, but all other paragraphs that are not affected will be applied within the limits permitted by law.
